### Ammon Underwood House, 587 CR 703, East Columbia, Brazoria County, Texas (Proposal to Move)

From East Columbia Historic District, NR nomination (1991, by Hardy-Heck-Moore):

**Description:** A 2-story frame dwelling with center-passage plan, the Ammon Underwood House is a modest vernacular interpretation of the Greek Revival style typical of the type built in Texas during the middle decades of the 19th century. Facing northwest onto Main Street, the dwelling is sheathed with wood siding and surmounted by side-gabled roof featuring composition shingles. An inset 2-tiered porch of 5 bays extends across the full width of the primary elevation. Detailed with square posts with molded caps, it features a balustrade on the second level. Fenestration includes single-door entrances with sidelights and transoms and double-hung wood sash with 6/6 lights on both levels. The Sweeny-Waddy House, relocated to rear of the property for use as a museum facility in the 1970s, is classified as a Noncontributing element of the district.

**Significance:** The Ammon Underwood House (NR 1976) is best known as the 50-year residence of Texas pioneer Ammon Underwood. Built in 1835 by Thomas W. Nibbs, a lawyer from Alabama, the house originally was a two-room frame dwelling. An unsuccessful law practice caused Nibbs to move to Fort Bend County to start a plantation in 1838, whereupon he sold the house to Ammon Underwood (Williams 1976).

Underwood came to Texas in 1834 from Massachusetts, arriving at East Columbia in April of that year. After working for several businesses in nearby communities, Underwood established a mercantile business in East Columbia with partners John P. Coles and David H. Milburn. Underwood joined the Texas Army in November 1835 and was appointed shortly thereafter to head the post commissary at East Columbia. After the Texas Revolution, he served as the town's postmaster from 1836 to 1845 (Webb 1952, II 817-818). Underwood purchased the house from Nibbs in partnership with Mrs. Catherine Carson, one of Stephen F. Austin's first 300 colonists. In establishing a boarding house for the growing town, they transformed the building into a 2-story frame building of four rooms and a kitchen ell (Williams 1976). The dwelling faced Front Street overlooking the Brazos River. Upon Underwood's marriage in 1839 to Catherine Carson's daughter, Rachel, the boarding house was closed and the building served as the family residence.

While Underwood lived in East Columbia, he amassed a considerable fortune through the operation of two large cotton plantations in Brazoria County. In the 1860s Underwood's plantation hands labored to move the house away from the eroding banks of the Brazos River. Despite the loss of his fortune during the Reconstruction Era, Underwood was elected to the 19th Texas Legislature in 1884 as a representative of the Brazoria district. He served on various committees including finance, insurance, statistics and history, and public buildings and grounds. Although he had earlier conveyed it to his son, Joseph, Underwood lived in the East Columbia house until his death in 1887 (Brazoria County Deed Records P:273).

Joseph Underwood took over the house and his father's mercantile business in East Columbia. As the Brazos River continued to erode the lot, he was forced to move the house a second time before 1900. With this move the structure was divided and the half placed on an adjoining lot was destroyed in the 1900 hurricane. The remaining half was repositioned on the lot to face Main Street (Williams 1976). After Joseph's death in 1925, his children, John and Laura, gained title to the property and lived there for over three decades. The river bank again gave way in 1937, compelling the Underwood's to remove the rear kitchen ell and relocate the dwelling to its current position on the lot. In 1968 the house was acquired by the First Capitol Historical Foundation and converted it into a museum depicting early republic-era life in Texas (first Capitol Historical Foundation, Inc.). 



<sup>&</sup>lt;sup>1</sup> Please note that the relocation site was recently surveyed, and the juxtaposition of the survey map onto the original district map reveals that the 1990 district map does not accurately show the location of the river. Since the eastern district boundary has not been resurveyed in its entirety, the revised map only shows the location of the river at the north end of the district. The written boundary description of the district refers only to the river as the east boundary and remains valid, despite subsequent erosion.


### 1. East Columbia Historic District map (as submitted to NPS, 1990; Underwood House is Site 15).




**3. Map showing location of house prior to 1975** (map from Ammon Underwood House NRHP nomination supplemental files; modified by THC staff 2005).










Re: Ammon Underwood House

Over a year ago, I contacted Dan Utley, Amy Hammons, and Jeffrey Harris about the necessity of moving the Ammon Underwood House . The Underwood House sits on the bank of the Brazos River. The river curves into the bank directly behind the Underwood House . The bank sloughs with each big rain, so that the house is in danger of falling into the river.. I have sent you information about the historic importance of the Ammon Underwood House and the Underwood Family.

This house was named a Recorded Texas Historic Landmark in 1970, was listed in the National Register of Historic Places in 1976. It is situated in a multiple property historic district listed in the National Register of Historic Places in 1991. We want to maintain our historic designations

According to s60.14 changes and revisions to properties listed in the National register

- (b) Relocating properties listed in the National Register
- (1) The house is be moved because it is in imminent danger of having the ground beneath it slough off into the Brazos River. It is to be moved a few lots north of its present location to a deeper lot, farther away from the Brazos River bank. It will be moved from 587 CR703, to 505 CR 703., This is on the same side of the street, still within the East Columbia Historic District.
- (2) It is desired that the property remain in the State Historic Preservation Program, based on the following documentation
- (i) The house must be moved because the Brazos River cuts into the bank directly behind the Ammon Underwood House and the house is in imminent danger from the river
- (ii) the effect on the property's historical integrity will be negligible since it will be located within a few lots of its original site, surrounded by historic houses, still within the East Columbia Historic District
- (iii) The new setting and general environment of proposed site is the same. Shovel tests reveal no historical or archeological remains on the new site, which is in keeping with the deed search and historical records.

.The Ammon Underwood House, built in 1835, is one of the oldest houses in Brazoria County. It is valued because of its significance at the time of the Republic of Texas, and the political importance of its owner, as well s its age and method of construction. It is a Recorded Texas Historic Landmark and listed on the National Register of Historic Places.

It has been nominated as an Endangered Historic Property on the Texas' Most Endangered Places list.

The Ammon Underwood House is owned and operated by the First Capitol Historical Foundation organized for the sole purpose of preserving and maintaining the Underwood House and other historic structures. The Foundation was chartered in 1967 and designated as a public foundation in 2003. (Letters from Treasury Dept. Are attached)

### **Need for Project**

The Underwood House is located on the banks of the Brazos River, and has been moved three times to escape the crumbling river banks. It is once again in critical danger. Heavy rains caused the loss of about 20 feet or river bank recently. The house must be moved (see attached maps)

### **Cost of Project**

Sixty five thousand dollars is needed to move the house and make restoration of the house (see attached budget)

## **Scope of Activities:**

Preserving and exhibiting one of oldest houses in Texas

Presenting the history of its owners and their part in Texas history

Preserving and exhibiting the only remaining slave cabin in Brazoria County

Presenting furnishings that are original to the house of representative of the period

Exhibiting a way of life during days of the Republic

School tours from 8 school districts in county will have a learning classroom as they visit a historic home and a slave cabin

Tract One above is located in Block 8 which is included in the East Columbia Historical District. It is requested that the East Columbia Historical District be expanded to include Tracts Two and Three.



This is to request your help in expediting authority to move the Ammon Underwood House. Time is truly of the essence.

The Brazoria County Judge and our Brazoria County Commissioner have allocated funds out of the Brazoria County Community Development Funds, to move the house to a safe location. However, Nancy Friudenberg, the CDF director, is unable to release the money for moving the house until she has a letter from the National Register program giving authority to move the house.

There are several procedures that must be followed before this money is dispersed, advertising for bids, letting bids, etc., all of which will take time. This money needs to be spent by September, out of this year's budget.

Also, the grant from Dow was given with the understanding that the project would be completed within one year, which ends September 1.

We have acquired property where the house will be moved, made provision for packing and storing the furniture, contacted a reputable mover, but we are unable to do anything further until we receive authority from the National Register Program to move the house

Enclosed is documentation outlining a proposal to move a building listed in the National Register of Historic Places (Ammon Underwood House, East Columbia, Brazoria, Texas). This documentation was submitted by Beth Griggs, President of the First Capitol Historical Foundation, with assistance from THC staff, to fulfill the requirements of the National Historic Preservation Act [36 CFR 60.14 (b)] regarding the relocation of properties listed in the National Register of Historic Places.

The Ammon Underwood House was individually listed in 1975, and is also a contributing property in the East Columbia Historic District, listed in 1991. The house was moved three times on the same lot prior to listing in 1975. The documentation argues that the Brazos River has eroded the lot over the years, and that keeping the building in place puts the building at great risk. The First Capitol Historical Foundation has received a private foundation grant and federal and county funding to move the building this summer.

The relocation site was chosen to take the house far from the river bank, just to the north of the East Columbia Historic District. A site within the district was considered, but the owners, the State Board of Review, and the Texas Historical Commission agree that given the recent erosion of the riverbank (and the likelihood of continued erosion), the house should be moved as far from the bank as possible, but still retain its orientation and setting on a lot immediately adjacent to the district. The State Board of Review approved the relocation of the house at its meeting on May 21, 2005, and has determined that the building should remain individually listed in the National Register if moved as proposed. All procedures outlined in 36 CFR 60 have been met.

We request your determination regarding whether or not the Ammon Underwood House could remain listed in the National Register in its new location. 



The complaint and notice of investigation named three respondents ZF Meritor, LLC of Maxton, North Carolina, ZF Friedrichshafen AG of Freidrichshafen, Germany, and ArvinMeritor, Inc. ("ArvinMeritor") of Trov. Michigan.

On January 7, 2005, the ALJ issued his final ID on violation and his recommended determination on remedy and bonding. The ALJ found a violation of section 337 by reason of infringement of claims 15 of the '279 patent by respondents. He found no violation of section 337 regarding the '566 and the '545 patents. Petitions for review were filed by Eaton, the respondents, and the commission investigative attorney



### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ammon Underwood house, located between Main Street and the Brazos River in East Columbia, is an early representative of the vernacular Greek Revival style of architecture. Situated on a high bank just above the Brazos, the house affords a commanding view of the river. The Underwood house was built on lots 35 and 39 of block 10 and still stands on the eastern most portion of lot 39. The house has been moved twice to avoid the encroachment of the river, since all of lot 35 and part of lot 39 have gradually been eroded (see

sketch map).

Stylistically, the Ammon Underwood house is a hybrid between the Greek Revival and the early pioneer-anglo Texas houses. The result is a house that evolved in Texas due to the adptablilty and ease of simplification of the Greek Revival. The early Texas house incorporated a row of posts acorss the front supporting the roof. The Underwood house took this basic form and transformed it into a Texas version of the Greek Revival by simply enlarging the posts into square columns with added molding for a capital, using a proportionally heavier beam for an entablature, and capping it with a simple cornice. The Underwood house combined the double gallery of the two-story Greek Revival and the lines and simplicity of the early double-room frame houses.

The Ammon Underwood house originated as a two-room one-story frame structure built in 1835-36. The framing in the walls was of hand-hewn cedar which was wood-pegged. Hand-made bricks were stacked between the studs for insulation and strength. All interior walls and the exterior wall under the porch were plastered. This original structure is incorporated into the existing building as the first floor on the north end of the house.

In 1838 the house was enlarged considerably for use as a boarding house. It was built then as it exists today with the exceptions of a portion of the house which was removed before 1900 and the kitchen ell removed in 1937. Before 1900 the house was moved to an adjacent lot for use as an independent residence. The other residence was completely destroyed in a 1915 storm. The house was turned at this time to face Main Street rather than the river as it had in its first location.

The last move, in 1937, saw the removal and abandonment of the kitchen ell which was hanging over the river after the bank again crumbled. The existing house, which contains the original 1835-36 construction, plus the additions made by Ammon Underwood in 1838, has been moved, but always on the same lot, in an effort to escape the encroach-

ment of the Brazos River.

The house today is distinguished by its full-length double gallery incorporated into the main body of the gabled roof. Square columns support the gallerys with their spacing from each other decreasing toward the center. The central hall is entered through a transomed side-lighted panel door at each level. At the rear of the central hall is a 1937 addition which contains a new stair landing and a pair of four-light double doors. The southwest corner of the house, with an exterior door on the south wall, was added at this time where the kitchen ell was removed. A rear double gallery stretches from the 1937 addition to the north wall and is covered by a shed roof. Access to the gallery is via three doors on each floor. All windows are uniform six-over-six light, double-hung sash with original outside louvered blinds now being refurbished.

The Underwood house is in the process of being restored. It has been leveled with a new concrete pier foundation which will receive a brick veneer. A new wood shingle roof has been put on, and the structure has been painted to stop deterioration. The galleries have been rebuilt from material salvaged from other vintage houses, and broken window panes have been replaced with glass of the same period. The two 1835-36 rooms have had their walls stripped of their original plaster which will be replaced.

The exterior porch walls, missing their plaster for many years, will also be replastered. The house is now the property of the First Capitol Historical Foundation Inc., which is responsible for its restoration and upkeep.

STATEMENT OF SIGNIFICANCE

The Ammon Underwood house, a significant example of pioneer-anglo architecture in Texas, was the home for nearly fifty years of the prominent businessman, plantation owner, Texas revolutionary soldier, and Texas legislator, Ammon Underwood. The original structure was built in 1835-36 by Thomas Nibbs and enlarged by Underwood in 1838. The house, located in East Columbia, is the oldest existing residence there. Although the house has been moved two times to avoid the encroaching river, it still stands on the original lot.

When the Underwood house was built, the community was known as Bell's Landing for its founder in 1823, Josiah Hughes Bell. At that time it was the head of navigation on the Brazos River, and was the most important shipping point in Stephen F. Austin's first colony, having a considerable volume of import and export trade due to the large

sugar and cotton plantations in the area.

In 1835 Thomas Nibbs (1807-1844), a lawyer from Alabama, constructed the first building on the site above the Brazos River at Bell's Landing. Nibbs built a simple two room, one story hand-hewn log frame structure as his homestead. He lived there until his lack of success as a lawyer caused him to move to Fort Bend County where he started a plantation. Nibbs sold the property to Ammon Underwood on October 15, 1838. Underwood immediately enlarged and improved the buildings constructed by Nibbs.

Ammon Underwood (1810-1887) came to Texas from Boston, arriving at Velasco on April 10, 1834. After working for several businesses in various communities Underwood chose to settle in Columbia where he went into partnership in a mercantile business with John P. Coles and David H. Milburn. For fifty years Underwood continued in the mercantile business in Columbia where his firm owned a large two-story brick building with its own warehouse on the banks of the Brazos. In November, 1835, the revolutionary war with Mexico had become acute in Texas and Underwood joined the Texas Army, taking part in the siege of Bexar and the Battle of Old Mill before being appointed head of the post commissary at Columbia. After the war, Underwood was postmaster at Columbia from 1836-1845.

In 1838 Ammon Underwood entered into another business partnership, this time with Mrs. Catherine Carson. Mrs. Carson settled on the Bernard River in 1824 as one of Stephen F. Austin's first three-hundred colonists. Together they financed the enlargement and improvement of the house on the Brazos River which they opened as a much needed boarding house in the thriving community. Mrs. Carson presided over the establishment until the marriage of her daughter, Rachel, to Ammon Underwood in 1839. The boarding house was discontinued then, and the building became the Underwood's residence.

Underwood owned a large plantation in addition to his business holdings, but he continued to live in town. The multi-talented Underwood also represented the Brazoria District in the Nineteenth Texas Legislature in 1884, as well as being the local correspondent for the Galveston News. Ammon Underwood died at East Columbia in 1887, and was survived by his wife and four children who remained in the house.

The Underwood house was first moved around the time of the Civil War when a fissure was found running from the river through the yard and under the house. Slaves were used to move the house more than the width of the house away from the river. The river continued to erode the lot, and the house was moved back from the river again prior to 1900. At this time the house was divided. A portion of the house was moved to an adjacent lot and used as an independent house until being destroyed in a hurricane in 1915. The remaining part of the house, including the original 1835-36 structure, was turned around 180 degrees to face the street rather than the river, with the kitchen "ell" extending toward the river. In 1937 the river bank again gave away, this time under the kitchen, leaving it partially suspended over the river. At this time the house was moved on the same lot, up to the street.

Joseph Underwood (1845-1925), Ammon's son, lived in the house and continued the mercantile business. Joseph's children, John Underwood (1879-1929) a merchant and County Commissioner, and Laura Underwood (1877-1966) continued to live in the house until 1958. The house is now the property of the First Capitol Historical Foundation, Inc. which is responsible for its upkeep. The house will be used for exhibition purposes, as it was given to the Foundation by the Underwood family with the proviso that it only be used for this purpose. Restoration of the house is in process. The portion of the house remaining after the 1915 storm, including the original 1835-36 structure, will be returned to its ca. 1840 appearance of the period when Columbia was the capitol

of the Republic of Texas.






Ammon Underwood House back (east) side - facing river


